# IMPLEMENTING AN eSmart FRAMEWORK @BPPS

## Brentwood Park Primary School is now in the 'Implementing Stage' of the eSmart Framework.

This means that across the six domains described in the 'eSmart Framework' (http://www.esmart.org.au) Brentwood Park Primary School has policies, procedures, practices and protocols set in place to deliver, promote and model smart, safe and responsible use of Information and Communication Technologies.

### DOMAIN ONE: EFFECTIVE SCHOOL ORGANISATION

- \* Brentwood Park Primary School has an eSmart committee which is a sub-committee of the Brentwood Park Primary School Management Team. This team meets fortnightly and comprises of representatives from all levels of the school. The aim of this committee is to guide the school community in the process of delivering smart, safe and responsible technology and wellbeing outcomes for all.
- \* Brentwood Park Primary School provides clear and consistent approaches when supervising students and their use of information and communication technologies.
- \* Brentwood Park Primary School collects ethical data annually. There are currently 3 types of data collected:
- 1 Equipment and devices audit;
- 2 Staff Professional Development;
- 3 Student Survey
- \* Students at Brentwood Park Primary School are encouraged to report incidents related to bullying including cyber bullying and any other inappropriate online behaviours by:
  - reporting directly to the teacher.
  - reporting to a staff member with the assistance of another student.
  - reporting in writing to a staff member.
  - reporting to an adult/guardian at home and then seeking advice and assistance from the school.
  - reporting by means of emailing or in writing.

All incidents of bullying in any form will be taken seriously by BPPS Staff. Staff will refer to the ICT Student User Agreement to ascertain if a breach of this agreement has occurred. The Principal and teacher/s will discuss possible actions and a plan of management will be enforced and monitored.

\* New students and their families enrolled at Brentwood Park Primary School will be provided access to the Information and Communication Technologies Policy and given the opportunity to discuss the procedures outlined in the policy with the Principal, Assistant Principal and/or the Class Teacher.

## DOMAIN TWO: SCHOOL PLANS, POLICIES AND PROCEDURES

\* Brentwood Park Primary School has an up to date ICT Policy and eSmart Policy. At Brentwood Park Primary School we recognise the need to integrate ICT throughout the curriculum. Teaching and learning at Brentwood Park Primary School aims at supporting, enabling and engaging the

learner in the contemporary world. Brentwood Park Primary School refers to the 'eSmart Framework', which enables positive and safe use of Information and Communication Technological equipment.

- \* BPPS has a whole school Student Well Being and Discipline Policy which guides staff to sensitive and consistent approaches to manage negative behaviour and guides student behaviour whilst at school. Plans, procedures and protocols are in place to promote positive student behaviour at Brentwood Park Primary School and are aligned with the Brentwood Park Primary School Purpose Statement and Beliefs About Learning.
- \* Brentwood Park Primary School uses User Agreements to provide a common and agreed approach to safe, smart and responsible use of Information and Communication Technologies. Copies of all 'User Agreements' can be found in the Brentwood Park Primary School ICT Policy. (see attachments)

#### DOMAIN THREE: A RESPECTFUL AND CARING SCHOOL COMMUNITY

- \* Brentwood Park Primary School's policies and procedures are governed by the values and beliefs set out in the Brentwood Park Primary School purpose Statement.
- \* Staff and students at Brentwood Park Primary School use the Brentwood Park Primary School ICT Policy is a document which guides the daily use of Information and Communication Technologies in conjunction with the BPPS Wellbeing and Discipline Policy to ensure all members of the school community work in a safe, respectful and secure environment.
- \*Brentwood Park Primary School uses mixed groupings, buddy systems, peer groups, and collaborative teams across the course of the year to enhance learning and teaching environments and to promote healthy and respectful relationships across and within school levels.

### DOMAIN FOUR: EFFECTIVE TEACHER PRACTICES

- \* BPPS plans, implements, develops and assesses student social and emotional learning.

- \* Brentwood Park Primary has a plan to deliver explicit teaching of safe, smart and responsible ICT behavior and practices by integrating learning outcomes in this area of the curriculum.
- \* BPPS staff are aware that the current Antibullying and Harassment Policy includes cyberbullying. Staff at Brentwood Park Primary School are familiar with revisiting, reflecting on

and improving strategies and resources to implement rich, relevant and 'best practice' strategies to educate the students and wider community about the importance of responsible digital citizenship.

- \* Brentwood Park Primary School has a current 'Cybersafety Scope and Sequence' document which outlines specific areas addressed at various grade levels.
